2. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue any department of the University of Great Falls from any and all liability to each of the undersigned his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise.
5. Authorize all medical, surgical diagnostic and hospital procedures as may be performed or presented by a physician for the above said participant if I cannot be reached in case of emergency.
