1 1111 THE BOARD OF TRUSTEES

- 2 Election
- 3 Elections conducted by the district are non-partisan elections governed by the general election laws as
- 4 found in Titles 13 & 20 of the Montana Code Annotated. The ballot at such elections may include
- 5 candidates for trustee positions, various public policy propositions and advisory questions.
- 6 Board elections shall be held on the first (1st) Tuesday after the first (1st) Monday in May of each year.
- 7 Any person who is a qualified voter of the District is legally qualified to become a trustee. A declaration
- 8 of intent to be a candidate must be submitted to the Cascade County Elections Office at least forty (40)
- 9 days before the regular school Election Day at which the person is to be a candidate. If there are
- different terms to be filled, the term for which each candidate is nominated shall be also be indicated.
- 11 Any person seeking to become a write-in candidate must file a declaration of intent no later than 5:00
- p.m. on the day before the ballot certification deadline in 20-20-401, MCA.
- 13 If the number of candidates filing for vacant positions or filing a declaration of intent to be a write-in
- candidate is equal to or less than the number of positions to be elected, the trustees may give notice no
- 15 later than thirty (30) days before the election that a trustee election will not take place. If the trustee
- 16 election is not held, the trustees shall declare the candidates elected by acclamation and issue a
- 17 "certificate of election" to each candidate.
- 18 A candidate intending to withdraw from the election shall send a statement of withdrawal to the
- 19 Cascade County Elections Administrator (Clerk & Recorder) containing all information necessary to
- 20 identify the candidate and the office for which the candidate has filed. The statement of withdrawal
- 21 must be acknowledged by the Cascade County Election Administrator. A Candidate may not withdraw
- after 5:00 p.m. the day before the ballot certification deadline in 20-20-401, MCA.
- 23 The ballot certification deadline in 20-20-401, MCA is not less than 30 days before an election.
- 24 In the event of an unforeseen emergency occurring on the date scheduled for the funding election, the
- district will be allowed to reschedule the election for a different day of the calendar year.
- 26 In years when the Legislature meets in regular session or in a special session that affects school funding,
- 27 the trustees may order the election on a date other than the regular school election day in order for the
- 28 electors to consider a proposition requesting additional funding under § 20-9-353, MCA.
