5 Pandemic Emergency Measures

6
7 School District Meetings, Gatherings, Events, and Visitors

8
9 The District has adopted the protocols outlined in this policy to govern during the term of the
10 declared public health emergency to ensure individuals present at a school facility for events or
11 other operationally related reasons honor safety protocols. The principal, Superintendent or
12 designee personnel are authorized to implement this policy in coordination with state or local
13 health officials.

14
15 School District Events

16
17 The Superintendent or his/her designee may authorize District physical meetings, gatherings, and
18 events when the event is deemed essential to District operations. Physical meetings, gatherings,
19 and events shall not be held without prior authorization of the Superintendent or his/her
20 designee.

21
22 All attendees at physical meetings, gatherings, and events held on school property in an outdoor
23 area including the stadium field, or other open area designated by the Board of Trustees shall be
24 required to honor the applicable health and safety protocols outlined in District Policy 1905
25 including, but not limited to, physical distancing. The District shall provide suitable space for
26 physical distancing to occur and, if practicable, markings and walking routes in the area where
27 the event shall be held to preserve a safe event setting.

28
29 Physical meetings, gatherings, and events shall be consistent with the guidance from state and
30 local health officials. All attendees at a meeting, gathering, or event authorized by the District are
31 required to honor the health and safety protocols outlined in District Policy 1905.

32
33 Vulnerable individuals (defined by the Centers for Disease Control) should not attend District
34 meetings, gatherings, or events held in accordance with this policy. Precautions must be taken to
35 isolate from vulnerable residents. The District shall accommodate vulnerable individuals so they
36 may participate in the meeting, gathering, or event via electronic means.

37
38 Visitors to School

39
40 Visitors to the interior of any school building shall not be permitted without the express approval
41 of the principal, Superintendent or designee. Visitors that are authorized to be present in any
42 school building must adhere to all health and safety guidelines outlined in District Policy 1905.

1 Volunteers

2

3 Volunteers utilized by the District that have been approved in accordance with District Policy
4 5430 may enter the school building in accordance with the protocols outlined in District Policy
5 1905.

7 Facilities Use Agreements

8

9 The District suspends community use of the District facilities. Unless an event is specifically
10 identified as necessary by the Superintendent or his/her designee, Facilities Use Agreements and
11 other similar request submitted in accordance with District Policy 4330 shall not be considered
12 while this policy govern the period of a public health emergency.

14 Enforcement

15

16 Visitors to any school building or any attendee at a meeting, gathering, or event authorized by
17 the Superintendent or his/her designee in accordance with this policy who fail to honor the
18 requirements of District Policy or the directives of District officials shall be asked to correct their
19 conduct or leave the meeting, gathering, or event in accordance with District Policy 4315.
