5 Conduct on School Property

6

7 In addition to prohibitions stated in other District policies, no person on school property shall at
8 any time:

9

- 10 1. Injure, haze, harass, intimidate, bully, or threaten to injure another person;
- 11 2. Damage another’s property or that of the District;
- 12 3. Violate any provision of the criminal law of the state of Montana or town or county
13 ordinance;
- 14 4. Use, possess, distribute, purchase, or sell tobacco products, including but not limited to
15 cigarettes, cigars, snuff, smoking tobacco, smokeless tobacco, nicotine, electronic
16 cigarettes and any other tobacco/nicotine innovation;
- 17 5. Consume, possess, ~~or~~ distribute, or be under the influence of any alcoholic beverages,
18 marijuana, or illegal/controlled substances;
- 19 6. Possess weapons (as defined in Policy 3310/3311);
- 20 7. Impede, delay, or otherwise interfere with the orderly conduct of the District’s
21 educational program or any other activity occurring on school property;
- 22 8. Enter any portion of the school premises at any time for purposes other than those that are
23 authorized by the District as public or educational activities.
- 24 9. Willfully violate other District rules and regulations.

26 “School Property” means within school buildings, in vehicles used for school purposes, or on
27 owned or leased school grounds.

28

29 As circumstances warrant, appropriate action will be taken by the District’s administrators.
