NON-INSTRUCTIONAL OPERATIONS

Food Services

The District shall provide school meals which meet or exceed the nutritional standards required by state and federal school lunch programs.

To encourage the eating of nutritious lunches and be in compliance with the Competitive Food Rules in Schools and the National School Lunch Program regulations, competitive food services shall not be permitted to operate anywhere on school premises. Only foods and beverages that meet or exceed the USDA Smart Snacks in Schools nutrition standards may be sold or served on the school campus during the school day. The school day is defined as the time between midnight the night before to 30 minutes after the end of the official school day. The School Campus is defined as all areas of the property under the jurisdiction of the school that are accessible to students during the school day. Any food and beverage sales of an occasional nature must comply with the nutritional requirements during the school hours. This includes school stores, snack bars, vending machines, ala carte items in the cafeteria and applies to all grade levels.

Because of the potential liability of the District, the food services program shall not accept donations of food without the approval of the Food Service Director, who has been delegated this function by the Board. The Superintendent shall establish inspection and handling procedures for the donated food and determine that the provisions of all state and local laws have been met before selling the food as part of school meals.

As an integral part of a school, the District's food service is operated in compliance with ARM Title 37, chapter 110, subchapter 2, rules for food services establishments.

Meal Prices

It is the Board's desire that the price of school meals be sufficient to cover costs of the meals, including preparation labor, food costs, handling costs, utility costs, and equipment depreciation costs and not direct resources away from the schools' instructional program. The District will follow the pricing guidelines established in the Healthy, Hunger-Free Kids Act of 2010.

Commodities

The District shall participate in the Federal Food Commodity Program for school meals.

Free and Reduced-Price Food Services

The District will provide free and reduced-price meals to students according to the terms of the National School Lunch Program and the laws, rules and regulations of the state. Applications are available in paper form on request at the schools and the food service office or parent/guardians may apply on line. The District will inform parents of the eligibility standards for free or

1 reduced-price meals by sending the result letters by mail or email as available. It is the parent or 2 guardian's responsibility to ensure the correct mailing and email address are on file at the school. 3 Identity of students receiving free or reduced-price meals will be confidential in accordance with 4 the National School Lunch Program guidelines.
